Sub : Retirement of Police Officers/Police Personnel/Ministerial Staff/Drivers/CF/PTS on superannuation during the year 2017-list publishing of reg.

Ref : GO (p) No.170/2012/Fin dated 22/03/2012

The list of Officers/Police Personnel/Ministerial Staff/Dvr/CF/PTS of this Unit who are due to retire from service on superannuation with effect from the AN of the last of day the month in which they attain the age of 56 years, (in case of PTS 70 years), during the year 2017 is furnished below. They will be relieved of their duties on the due date after collecting back all the government properties which are to be surrendered before their retirement from service and they would not be retained in service beyond that date on any account. Liabilities, if any outstanding against these retiring personnel should be assessed and reported to this office sufficiently early to effect the recovery from their last pay. Separate report should be sent by the Station House Officers/Unit Heads concerned to this office soon after the officer concerned is relieved of his/her duties on retirement.

If anyone is received on transfer from any other unit and if anyone is reinstated into service after suspension/dismissal is found due for retirement on superannuation during the year 2017 after the issue of this C.O., their Name, Rank, Date of Birth etc should be reported to this office by the officers concerned under whom he is working without fail for verification and incorporation of their names.

The Commandant, AR, Thiruvananthapuram City, all Sub Divisional Police Officers, Circle Inspectors and Station. House Officers are hereby directed to verify the date of birth of all police personnel working under them with reference to their SSBs/MH Sheet etc. and report immediately to this office if the name of any person who is due to retire from service during the year 2017 was excluded from the list. If any error is noticed in this list after verification, the fact should be reported to this office forthwith.

It may also be noted that if anybody happens to be retained in service and draw/receive pay and allowances after the date of retirement, the officer concerned and the SHO/Unit Head concerned will be held responsible for the lapse.

The Unit Heads/sections concerned in CPO, Thiruvananthapuram, Secretary, Police Staff Cooperative Society, Vazhuthacaud and KPHCS, Ernakulam will furnish report on liabilities towards Government/Quarters/water charges/electricity charges/professional tax/leave settlement/KPW & A fund loans/ AdvanceTA/ excess pay drawn /MCA/HBA/IFMA/CA/Telephone Charges/Departmental disciplinary proceedings (OE/Non-OE) Crime Case/Vigilance enquiry etc. pending against those retiring employees sufficiently early, so that their pensionary benefits can be released without delay.

Copies of this C.O. will be circulated among each personnel whose name is included in the list and obtain their dated signature on the list against their names and returned to this office through iAPS duly certified by the Station House Officer/Unit Heads to the effect that:-

1) Certified that the list has been circulated among all concerned working in this

station/unit, obtained their dated signature and that nobody is excluded from the list.

2) And that the list has been verified and found correct and none of this unit due to retire from service during the year 2017 has been excluded. (If excluded the name, rank, designation, date of birth, date of retirement etc may be furnished for the inclusion in the list). The Unit Heads/SHOs concerned should forward the following reports to City Police Office, Thiruvananthapuram within 2 days from the date of retirement of the employee concerned.

1. Liability/Non Liability report.
2. Non Leave Roll Pending report.

The Officers concerned will direct the personnel to submit formal application for pension with the following documents to them for onward transmission to City Police Office, Thiruvananthapuram City.

1. Pension Book (2 Nos)
2. Descriptive Roll & Identification particulars (duly attested by the CI concerned) - 2 Copies.
3. Specimen Signature (duly attested by the CI concerned - 2 Copies.
4. Left hand thumb & finger impressions (Duly attested by the CI concerned) – 2 Copies.
5. Passport size photographs (Single / Joint) (Duly attested by the CI concerned) – 3 copies each.
6. Nomination for lifetime arrears of Pension (Form A) (attested) – 2 Copies.
7. Permanent Address with Telephone Number/Mobile Number after retirement – 2 Copies.

The retiring person will fill up the pages 5,23,27,29,31,33,37 & 41 of the Pension Book.

All Gazetted Officers may sent their formal application for pension along with the required documents to this office at least one year before their retirement without waiting for any intimation either from this office or from the Accountant General (A&E), Kerala.

On his/her option, the subscribers can stop the subscription to GPF account within one year of his/her retirement and apply for closure of account in advance. This chance can be utilized by the retiring personnel in order to receive their GPF closure amount without delay.

The Terminal Surrender of Earned Leave can be sanctioned to a retiring person immediately after his / her retirement without waiting for an application from the individual. The leave sections in City Police Office will ensure early action in regard to the settlement of EL accounts.

As per GO(P) 255/90/Fin. Dated 28/04/1990, the subscribers to FBS are given option to remit the subscription in lump for the last six months prior to retirement for speedy settlement of the claim. The retiring person can utilize the chance in time. He can submit application to City Police Office well before six months for the recovery of FBS subscription in lump. The FBS section in CPO will see that early action is taken to get the FBS account transferred to this district from other units. If the retiring person has worked in other units prior to retirement, much care should be taken to up-to-date the register –cum-broad sheet in respect of the individual. It should also be ensured that the reconciliation of the up-to-date account of the subscriber is done sufficiently early before the retirement of the subscriber.

As in the case of GIS, option for recovery in lump of six months premium to Group Insurance Scheme can also be made. But the final settlement of the scheme will be taken up only after the date of retirement of a person, to ensure continued insurance coverage envisaged in the scheme. Application in Form 3 should be obtained well in advance and the entries in the pass book made up-to-date. Proposal for final payment should be send to the Director of Insurance without much lapse of time.

In the case of lump-sum Grant from KPW&A Fund to a retiring employees as admissible in GO(MS)No. 1196/81/Home dated 03/12/1981, the amount should be calculated well in advance after obtaining the details of recovery of subscription from former units, if required. The concerned section will take early action in this matter.
