Sri.Soman HC T 6685 has entered in service on 1/3/1985. He has passed General HC test in Full vide CO No 876/95TC dtd 30/6/1995.He was under suspension from 29/9/2005 to 22/3/2013. So his promotion to the rank of HC was not allowed in his due turn.His immediate junior T6687 Vijayakumar was promoted as HC vide CO No.793/2008TC..So he has filed OA No753/2016 before the Hon Kerala Administrative Tribunal requesting to promote him as HC/ASI as their juniors were already promoted.The Hon Court has disposed the case by authorising the Govt to take a decision after hearing the applicants in person. The Govt vide letter No93187/A3/2015 dtd 15/12/2016 has directed this office to promote them as HCs irrespective of the criminal case pending in the trial court if otherwise eligible since Head Constable is not a selection post as envisaged under Rule 28(b)(ii) of KS&SSR.Hence T6685 Soman was provisionally promoted as Senior Civil Police Officer vide CO No.275/2017TC dtd 25/2/17. On verification of his service Book and other connected records he has passed the General HC test conducted in 7/3/1995 and found eligible for promotion as HC along with his junior T 6687 Vijayakumar.the HC promotion of his juniors and seniors was regularised vide CO No.952/2010 TC dtd 30/10/2010. The promotion of his immediate senior HCT 6684 Sunil kumar (SI No.580)was regularised wef 22/5/2008 and promotion of his immediate junior T6687 Vijayakumar (SI No581)was regularised wef 30/5/2008 dtd 30/10/2010.In these circumstances the promotion of Sri Soman T 6685 as HC is regularised wef 30/5/2008 ,the date on which his immediate junior was regularised and included in the CO No.952/2010TC dtd 30/10/2010 as SI No580(A) as furnished below
